#### **INSTRUCTION FOR ONLINE BID SUBMISSION**

The bidders are required to submit soft copies of their bids electronically on the Central Public Procurement (CPP) Portal i.e. <a href="http://eprocure.gov.in/eprocure/app">http://eprocure.gov.in/eprocure/app</a>, using valid Digital Signature Certificates. The instructions given below are meant to assist the bidders in registering on the CPP Portal, prepare their bids in accordance with the requirements and submitting their bids online on the CPP Portal.

#### REGISTRATION

- (i) Bidders are required to enroll on the e-Procurement module of the Central Public Procurement Portal (URL: <a href="https://eprocure.gov.in/eprocure/app">https://eprocure.gov.in/eprocure/app</a>) by clicking on the link "Online Bidder Enrollment" option available on the home page. Enrolment on the CPP Portal is free of charge.
- (ii) During enrolment/ registration, the bidders should provide the correct/ true information including valid email-id & mobile no. All the correspondence shall be made directly with the contractors/ bidders through email-id provided.
- (iii) As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.
- (iv) For e-tendering possession of valid Digital Signature Certificate (Class II or Class III Certificates with signing key usage) is mandatory which can be obtained from SIFY /nCode/eMudra or any Certifying Authority recognized by CCA India on e-Token/ Smartcard.
- (v) Upon enrolment on CPP Portal for e-tendering, the bidders shall register their valid Digital Signature Certificate with their profile.
- (vi) Only one valid DSC should be registered by a bidder. Bidders are responsible to ensure that they do not lend their DSCs to others which may lead to misuse and should ensure safety of the same.
- (vii) Bidders can than log into the site through the secured login by entering their user ID/ password and the password of the DSC/ eToken.

#### **SEARCHING FOR TENDER DOCUMENTS**

- There are various search options built in the CPP Portal to facilitate bidders to search active tenders by several parameters. These parameters could include Tender ID, organization name, location, date, value, etc. There is also an option of advanced search for tenders, wherein the bidders may combine a number of search parameters such as organization name, form of contract, location, date, other keywords, etc., to search for a tender published on the CPP Portal.
- 2) Once the bidders have selected the tenders they are interested in, they may download the required documents / tender schedules. These tenders can be moved to the respective 'My Tenders' folder. This would enable the CPP Portal to intimate the bidders through SMS / e-mail in case there is any corrigendum issued to the tender document.
- 3) The bidder should make a note of the unique Tender ID assigned to each tender, in case they want to obtain any clarification / help from the Helpdesk.

#### PREPARATION OF BIDS:

- (i) For preparation of bid Bidders shall search the tender from published tender list available on site and download the complete tender document and should take into account corrigendum if any published before submitting their bids.
  - After selecting the tender document same shall be moved to the 'My favourite' folder of bidders account from where bidder can view all the details of the tender document.
- (ii) Bidder shall go through the tender document carefully to understand the documents required to be submitted as part of the bid. Bidders shall note the number of covers in which the bid documents have to be submitted, the number of documents including the names and content of each of the document that need to be submitted. Any deviations from these may lead to rejection of the bid.
- (iii) Any pre-bid clarifications if required, then same may be obtained online through the tender site, or through the contact details given in the tender document.
- (iv) Bidders should get ready in advance the bid documents in the required format (PDF/xls/rar/dwf/jpg formats) to be submitted as indicated in the tender document/schedule. Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned document.
- (v) Bidders can update well in advance, the documents such as experience certificates, annual report, PAN, EPF & other details etc., under "My Space/ Other Important Document" option, which can be submitted as per tender requirements. This will facilitate the bid submission process faster by reducing upload time of bids.

#### **SUBMISSION OF BIDS:**

- (i) Bidder should log into the site well in advance for bid submission so that he/ she upload the bid in time i.e. on or before the bid submission time. Bidder will be responsible for any delay due to other issues.
- (ii) Bidder should prepare the EMD as per the instructions specified in the NIT/ tender document. The details of the DD/BC physically sent, should tally with the details available in the scanned copy and the data entered during bid submission time. Otherwise the uploaded bid will be rejected.
- (iii) While submitting the bids online, the bidder shall read the terms & conditions (of CPP portal) and accepts the same in order to proceed further to submit their bid.
- (iv) Bidders shall select the payment option as offline to pay the EMD and enter details of the DD/BC.
- (v) Bidder shall digitally sign and upload the required bid documents one by one as indicated in the tender document.
- (vi) Bidders shall note that the very act of using DSC for downloading the tender document and uploading their offers is deemed to be a confirmation that they have read all sections and pages of the tender document without any exception and have understood the complete tender document and are clear about the requirements of the tender document.

- (vii) Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned document. For the file size of less than 1 MB, the transaction uploading time will be very fast.
- (viii) If price quotes are required in XLS format, utmost care shall be taken for uploading Schedule of quantities & Prices and any change/ modification of the price schedule shall render it unfit for bidding.

Bidders shall download the Schedule of Quantities & Prices i.e. Schedule-A, in XLS format and save it without changing the name of the file. Bidder shall quote their rate in figures in the appropriate cells, thereafter save and upload the file in financial bid cover (Price bid) only.

If the template of Schedule of Quantities & Prices file is found to be modified/corrupted in the eventuality by the bidder, the bid will be rejected and further dealt as per provision of clause no 23.0 of ITB including forfeiture of EMD.

The bidders are cautioned that uploading of financial bid elsewhere i.e. other than in cover 2 will result in rejection of the tender.

- (ix) Bidders shall submit their bids through online e-tendering system to the Tender Inviting Authority (TIA) well before the bid submission end date & time (as per Server System Clock). The TIA will not be held responsible for any sort of delay or the difficulties faced during the submission of bids online by the bidders at the eleventh hour.
- (x) After the bid submission (i.e. after Clicking "Freeze Bid Submission" in the portal), the bidders shall take print out of system generated acknowledgement number, and keep it as a record of evidence for online submission of bid, which will also act as an entry pass to participate in the bid opening.
- (xi) Bidders should follow the server time being displayed on bidder's dashboard at the top of the tender site, which shall be considered valid for all actions of requesting, bid submission, bid opening etc., in the e-tender system.
- (xii) All the documents being submitted by the bidders would be encrypted using PKI (Public Key Infrastructure) encryption techniques to ensure the secrecy of the data. The data entered cannot be viewed by unauthorized persons until the time of bid opening. The confidentiality of the bids is maintained using the secured Socket Layer 128 bit encryption technology.

#### 4. Taxes

- c. Variation Clause: Any change (Increase / Decrease) in Govt. Duties / Leveis / GST as amended by Govt. (State / Central) from time to time will be applicable during the currency of Purchase Order / Contract & shall be borne by ALIMCO.
- d. The GST amount is payable only after reflection of GST credit in the Corporation's GST Portal.

<u>SUBMISSION OF EMD: -</u> All the Tenderers must submit **Rs. 25,000** /- by Demand Draft in favour of ALIMCO, KANPUR or Banker's Cheque as an Earnest Money Deposit. **No other mode is acceptable**. The EMD shall be released within 30 days of finalization of the Purchase Orders/ Contract to the unsuccessful Tenderers. No interest will be payable on the EMD.

Tenders without EMD / inadequate EMD are liable to be rejected irrespective of rates quoted. Exemption to submit Earnest Money Deposit (EMD) on submission of valid Udyog Aaadhar Memorandum (UAM) against Tender for the items/nature of business/ type of services specified therein in the UAM.

The earnest money will be forfeited if the tenderer withdraws his tender before the period of validity (i.e. minimum 90 days) and / or tenderer fails to furnish requisite security deposit within the specified period after the award of Order / Contract wherever applicable.

### 5. <u>Security Deposit</u>

Subsequent to placement of Order / Contract, the successful tenderer will be required to deposit a sum equal to **10** % **of the Order/ Contract value as Security Deposit** in the form of Demand Draft only in the favour of **ALIMCO** payable at **Kanpur**, within the period of 30 days from the award of work contract.

The Corporation, at its sole discretion may decide that in case of failure of the party to deposit balance amount of Security deposit, the same will be recovered @ 25% from the payments to be released against the running bills of the party.

This Security deposit will be retained till the expiry of contract plus one month. No interest shall be payable on this Security Deposit. After Satisfactory completion of contract for Deployment of trained manpower for Operation & management of Toll-free beneficiary care, service & redressal centre (Alimco toll-free call centre) and on receipt of request to release Security deposit, the same shall be released by ALIMCO, within 30 days.

The Corporation reserves the right to forfeit the security money deposit in case the supplier fails to make goods losses on supplies, unable to replace supplies found unacceptable as well as losses on account of exceptional delays in supplies.

#### 6. Rejection of Tender

- a) Conditional and unsigned tenders, tenders containing absurd or unworkable rates and amounts, tenders which are incomplete or otherwise considered defective and tenders not in accordance with the tender conditions are liable to be rejected.
- b) Canvassing in any form in connection with the tender is strictly prohibited and the tenders submitted by the party who resort to canvassing are liable to be rejected.
- c) The acceptance of tender will rest with ALIMCO which does not bind itself to accept the lowest tender or any tender and reserves full rights for the rejection of any or all tenders without assigning any reasons whatsoever.

# 7. Validity of Tender

- a) The tenders shall remain open for acceptance for a minimum period validity of 90 days from, the date of opening of tenders (T-Bid) or till such period up to which the extension of validity is agreed to mutually. This may please be stipulated clearly in the Quotation.
- b) If notified within this period that the tender has been accepted, the tenderer shall be bound by the terms of the offer along with the terms that have been agreed mutually.
- c) In case the tenderer happen to be dealer/ distributor for any reputed brand the validity certificate to this effect duly certified from the principal should invariably be provided.
- d) The tenderer must submit all the documents dully filled and signed as mentioned in mandatory/ Pre qualification criteria on page no. 2, failing which the offer will summarily be rejected.
- e) The successful tenderer shall not sub contract the assigned task covered under the work contract.

# 8. Terms of Payment

ALIMCO is a Schedule 'C' Miniratna Category II Central Public Sector Enterprises, registered under Section 8 (Not for Profit motive) of the Companies Act, 2013, (corresponding to Section 25 of the Companies Act, 1956)

- a) 75% Payment (excluding GST) will normally be released by ALIMCO on monthly basis for actual work done on receipt of monthly bills submitted by the successful tender for duly completed work after duly verification by Marketing Department regarding payment of minimum wages to the deployed manpower. Payment shall be made within 30 days from the date of receipt of bill.
- b) Balance amount after considering (a) above subject to the amount of actual payment of Minimum Wages, deposit of PF,ESI and other statutory due shall be released on submission of certified copies of challans of payment of PF, ESI duly attached with Form XII evidencing payment of minimum wages applicable for that month as per Central Government notification.
- c) The GST amount will be released on submission on GST monthly/ quarterly return (GSTR-1) duly certified by the tenderer, Further the GST amount will be released after confirmation of GST input credit through online. In case of non-matching of GST input credit, no payment of GST will be made by the Corporation.
- d) Supplier's Bank Charges/Draft making charges will have to be borne by the party only.
- e) The tenderer will be required to submit their RTGS details duly certified by the Bank or along with a crossed/ cancelled Cheque in support of the details, as all payments/ refunds are preferably be made through RTGS mode only.

#### 9. Right of Acceptance

Arbitration proceeding shall be held at Kanpur only and the Kanpur Courts will have jurisdiction in the matter.

- 2. In line with aforesaid objectives of ALIMCO and to further improve and existing service delivery system, ALIMCO propose to strengthen its present beneficiary Care cum Service and Redressal System.
- 3. For above purpose, ALIMCO is inviting sealed offers in online mode from parties who may be required to deploy the requisite trained manpower at ALIMCO, Kanpur for the operation and management of Toll-free beneficiary care, service and redressal centre (ALIMCO toll-free call centre) at ALIMCO, Kanpur. The broad scope of work are given as under:-
- i) To attend incoming calls on ALIMCO's toll free numbers, communicate & collect / provide information as per laid down procedure of ALIMCO.
- ii) Registering caller (beneficiary) information as per format provided by ALIMCO and responding queries of caller (beneficiary) based on information as provided by ALIMCO.
- iii) Maintaining and forwarding complete details of caller (beneficiary) to respective department through e-mail/ register on daily basis in respect of all incoming and calls being made to beneficiaries as per format / procedure laid down by ALIMCO.
- iv) ALIMCO has already established and commissioned Beneficiary Care, Service and redressal centre using its toll-free number at ALIMCO, Kanpur. Accordingly, tenderer is required to use the existing set up which is having two computer, head phone and two telephone lines including a toll-free number.
- V) Tenderer are required to deploy trained manpower to manage two seats between 8.00 AM to 8.00 PM on all days (holidays to be intimated by ALIMCO separately) at ALIMCO, Kanpur on minimum wages criteria to be ensured as per government rules & regulations. (ALIMCO TOLL-FREE CALL CENTRE may also open for all 365 days)
- vi) The tenderer are required to deploy their trained manpower having at least 1 to 2 years of experience of working and managing call centre activities. Calls are required to be

answered/made using Hindi language but in case of need to also required to be answered / made using English language.

- vii) Outgoing calls to be made to beneficiaries informing them for assessment and distribution camp also feedback calls on products and service part to be made on regular basis.
- viii) The tenderers are required to replace the resource (deployed manpower) on receipt of written request / notice from ALIMCO within a period of a week.
- ix) The provision for doing recording (on computer) of incoming / outgoing calls also needs to be made, accordingly tenderer are requested to quote their charges separately in their offer (BOQ) for providing recording facility. The recording of select call/calls for select date/month may require to be provided on CD/DVD as & when required by the Corporation/ at the end of the Work Contract.
