Dear Sir,

Kindly refer to two show cause notices dated 18/01/2017 and 08/02/2017 served by the Corporation upon you. By means of the final show cause notice dated 08/02/2017 you were called upon to explain the reason are as required vide said show cause notice along with documentary evidence.

In reference to the show cause notice dated 08/02/2017 you sent your reply dated 13/02/2017. By means of the said reply you simply reiterated your previous reply dated 24/01/2017.

The corporation is not satisfied with your reply dated 13/02/2017 and on the basis of the documents available with the Corporation, the Corporation is fully satisfied that you have concealed material facts to the effect of your previous conduct. It is established to the satisfaction of the Corporation that you have been debarred to participate in E-Procurement by the Thane Mahanagar Palika, Thane. Moreover, for your poor services your contract had been terminated by the Kerala Port Transport. Both these events on your part disqualified you from participating in the tender process.

Under these circumstances the Corporation exercises its right to terminate your contract (work contract no. PT/08/AU/WC dated 29.09.2016), for concealment of facts and breach of tender condition and accordingly your contract shall stand terminated on the expiry of 30-days from the receipt of this termination order.

You are further advised to submit all the documents of the Corporation forthwith which has been received by you through E-tender.

The security deposit shall be refunded to you as per rules.
