NOTICE

Invitation of Objection to the provisional list of Conditionally Shortlisted/ Not Shortlisted Candidates for the post of Manager (MR) [Post code- HR-12]

This has reference to advertisement no.AD3F01/Aug-2022 dated 08.08.2022 which was published in various newspapers i.e. Times of India dated 10.08.2022, Amar Ujala dated 08.08.2022, Employment News (English) dated 20.08.2022 & Rojgaar Samachar (Hindi) dated 20.08.2022. The same was uploaded with terms & conditions in the website of ALIMCO on 08.08.2022 for the post of **Manager (MR) (Post Code HR-12)**.

In all 17 Nos. applications were received for aforesaid post till the last date of receipt of applications by the Corporation i.e. 20.09.2022. No application were received after due date. The total 10 applications were scrutinized by a Scrutinizing Committee comprising of Senior Officials of the Corporation.
