Invitation of Objection to the provisional list of

This has reference to advertisement no.AD3F01/Aug-2022 dated 08.08.2022 which was published in various newspapers i.e. Times of India dated 10.08.2022, Amar Ujala dated 08.08.2022, Employment News (English) dated 20.08.2022 & Rojgaar Samachar (Hindi) dated 20.08.2022. The same was uploaded with terms & conditions in the website of ALIMCO on 08.08.2022 for the post of **Store Assistant MM (Plastics) (Post Code HR-53)**.


