

- 1.The call for Expression of Interest (EOI) is to explore Original Equipment Manufacturers (OEM), to identify and short-list capable OEMs only. Detailed offers with documentary evidences & applicable certificates as per Response Format (Table-1) of the Expression of Interest (EOI) is to be submitted on or before the Due date.
- 2. The evaluation of the offers / responses received will be evaluated by a Technical Evaluation Committee nominated by the Corporation. The Technical Evaluation Committee may call for a pre-bid meeting with the Parties who will submit their response against the EOI. The Corporation in its sole discretion has right to depute a Technical Evaluation Committee at evaluation stage of proposals against the Expression of Interest to visit the work place/Factory of the OEM to ascertain the capability/capacity, if felt necessary by the Corporation. The recommendation of the Technical Evaluation Committee regarding acceptance/non-acceptance of the offer/offers against the EOI shall be binding on the OEM / parties. No representation against the recommendation/decision of the Technical Evaluation Committee/Corporation shall be admissible/entertained.
- 3. In the second stage, Request for Proposal (RFP) will be issued to the short-listed OEM's only. The RFP will be under two-bid system i.e., Technical Bid (TC-Bid) and Price-Bid(P-Bid).

Objective of the EoI

ALIMCO invites EoI (Expression of Interest) from reputed Indian OEM (Original Equipment Manufacturer) having well established manufacturing facility for supply of white labelled (ALIMCO Name & Logo) <u>PERSONAL PROTECTIVE EQUIPMANTS – COVERALL (GARMENT)</u>, GOGGLES, N-95 MASK, NITRILE GLOVES, FACE SHIELF ,TRIPLE LAYERED SURGICAL MASK, HAND RUB SANITIZES, ETC.

Specification

1. Coverall (Garments) - Medium and large size, along with Shoe cover

- Impermeable to blood and body fluids
- Single use Avoid culturally unacceptable colors e.g. black.
- Light colors are preferable to better detect possible contamination
- Thumb/finger loops to anchor sleeves in place
- Quality compliant with following standards
 - a. Meets or exceeds ISO 16603 class 3 exposure pressure, or equivalent
 - b. Garments must be tested for Synthetic Blood Pressure Penetration Test conducted by SITRA Coimbatore for fabric, Garment, complete knitted suit and feet/Shoe cover. The test report must be submitted along with this bid.

Note: Bidders shall quote for the complete knitted coverall (for head to toe) or Complete knitted coverall up to ankle with separate price for feet/shoe cover.

2. Goggles

- With transparent glasses, Zero power, well fitting, covered from all sides with elastic band/or adjustable holder.
- Good seal with the skin of the face.
- Flexible frame to easily fit all face contours without too much pressure.
- Covers the eyes and surrounding areas and accommodates for prescription glasses
- Fog and scratch resistant.
- Adjustable band to secure firmly so as not to become loose during clinical activity.
- Indirect venting to reduce fogging.
- May be re-usable (provided appropriate arrangements for decontamination are in place) or disposable.
- Quality compliant with the below standards, or equivalent
 - a. EU standard directive 86/686/EEC, EN 166/2002
 - b. ANSI/SEA Z87.1-2010

3. N-95 Masks with and without Expiratory Valves.

- Shape that will not collapse easily
- High filtration efficiency
- Good breathability, with/without expiratory valve
- Quality compliant with standards for surgical N95 respirator:
 - a. NIOSH N95, EN 149 FFP2, or equivalent
- Fluid resistance: minimum 80 mmhg pressure based on ASTM F1862, ISO 22609, or equivalent
- Quality Compliant with standards for particulate respirator that can be worn with full face shield.

4. Face Shield

- Made of clear plastic and provides good visibility to both the wearer and the patient
- Adjustable band to attach firmly around the head and fit snuggly against the forehead
- Fog resistant (preferable)
- Completely covers the sides and length of the face
- May be re-usable (made of material which can be cleaned and disinfected) or disposable
- Quality compliant with the below standards, or equivalent:
 - a. EU standard directive 86/686/EEC, EN 166/2002
 - b. ANSI/SEA Z87.1-2010

5. Triple Layer Surgical mask

- Three layered surgical mask of non-woven material with nose piece, having filter efficiency of 99% for 3 micron particle size.
 - a. ISI Specification or equivalent

6. Gloves (Size 6.5, 7 & 7.5)

- Nitrile
- Non-sterile
- Powder free

- Outer gloves preferably reach mid-forearm (minimum 280mm total length)
- Different sizes (6.5, 7 & 7.5)
- Quality compliant with the below standards, or equivalent:
 - a. EU standard directive 93/42/EEC Class I, EN 455
 - b. EU standard directive 89/686/EEC category III, EN 374
 - c. ANSI/SEA 105-2011 ASTM D6319-10

7. Hand Rub Sanitizres (Size 50ml, 100ml,500 ml)

- Min 70% Ethyl Alcohol V/V.
- Dries quickly without leaving any residue.
- Usable any where without water and towel.
- Possesses remarkeable residual and persistent effect.
- Leaves hand soft with refreshing fragrance.
- Min 2 Years Shelf life.
- With Valid Drug Licance
- Quality compliant with the required standards

All items to be supplied need to be accompanied with certificate of analysis from national/international organizations/labs indicating conformity to standard.
