Introduction to ALIMCO

ALIMCO set up in 1972 by Government of India for manufacture and distribution of Aids & Appliances for persons with disabilities has emerged as one of the largest manufacturers of Artificial Limbs and Rehabilitation Aids in India today. ALIMCO's Headquarter is located in Kanpur near IIT, Kanpur, it is working under the aegis of the Ministry of Social Justice & Empowerment, Govt. of India.

ALIMCO produces various categories of products with about several variants under the following heads:

- Orthotic and prosthetic appliances
- Mobility Aids
- Aids for hearing Impaired
- Aids for visually handicapped
- Aids for mentally challenged
- Fitment Tools and Equipment
- Assistive Devices for Leprosy affected Persons

ALIMCO has a wide reach and rich experience of working with various stakeholders in the Disability space in India

Background to the request for EOI

Conservative estimates of disability prevalence in India, suggest that about 26.8 Million out of 1.25 Billion population are affected. These PWDs need Assistive devices.

There is robust growth in both rural and urban healthcare ecosystems in India, accompanied by an exponential per capita income growth.

Globally, significant technological advancements are being made in the development of various Assistive devices. Progressively new kinds of materials, technologies and tools are being used to produce devices which are lighter, stronger and more durable. Some of the indicative developments being:

- Use of advanced materials such as carbon fiber frame, silicon, copolymer, polyurethane etc.
- Advancement in Assistive Technology for Hearing, Visually & Mentally Impaired.

While ALIMCO has made significant progress in the space and has registered sustained growth over the last few years, however, to tap the expanding markets, focus on new geographies beyond India and address the needs of its existing customers through technologically advanced products, ALIMCO intends to undertake modernization of its product portfolio and technology.

Objective of the Eol

ALIMCO solicits expression of interest from leading global manufacturers in the space of Assistive Devices for PWD's to evaluate potential Joint Venture (JV) and/or Technology Partnerships.

• High level expectations from JV/ToT:

- Product development: Partnerships to procure modules and assemble them at its manufacturing or fitment centers is seen as a good way, for ALIMCO to offer high-tech products.
- Technology partnerships, transfer and licensing: The technology has advanced considerably in the past few decades. Products have become more sophisticated and are customized to an individual's needs. They provide higher functionality, are lighter and more useful or day to day activities. Licensing, technological up-gradation and subsequently manufacturing is part of ALIMCO's agenda to bring these benefits to its customers
- Product Innovation: India is a nation which has many cultures, practices, work environments, terrains etc. These factors dictate that Assistive Devices systems need high degree of localization to be effective. Collaborative technological innovations and new designs are needed to build products suited for the Indian milieu.

• Indicative Outcomes:
