**Sub: Financing of trade receivables of MSEs through TReDS (Trade receivables Discounting System) platform in ALIMCO Procurements.**

1. Cabinet secretary, Govt. of India informed vide D.O. letter No. 601/1/2/2017- CA.V dt.31st Oct that D/o financial services has established the trade receivables discounting systems (TReDS) which enables prompt en- chasing of receivables and advised to register on the TReDS platform.
2. Accordingly, ALIMCO has registered on TReDS platforms through M/s. receivables Exchange of India Limited (RXIL). Provision to avail financing of trade receivables of MSEs through TReDS Platforms was also implemented in ALIMCO.
3. As per this system, MSE vendors who are registered on specific TReDS platforms can upload the invoices on the TReDS Platforms and it goes to buyer for acceptance. Once the buyer accepted the invoices, then TReDS settle the amount through online by debiting the amount from financier account and pay the MSEs.
4. MSE vendors are requested to register with TReDS platforms through M/s. receivables exchange of India Limited (RXIL). In continuation for specific invoices MSEs can avail the facilities of TReDS platforms to receive their payment.
