### **Objective of the program:**

Assistance to Disabled Persons for Purchase/Fitting of AIDS/Appliance (ADIP Scheme): The main objective of the Scheme is to assist the needy persons with disabilities in procuring durable, sophisticated and scientifically manufactured, modern, standard aids and appliances to promote physical, social, Physiological rehabilitation of persons with disabilities by reducing the effects of disabilities and at the same time enhance their economic potential.

<u>ADIP-Sarva Shiksha Abhiyaan Scheme:</u> The main objective of the Scheme is to assist for school going Children with Special Needs in procuring durable, sophisticated and scientifically manufactured, modern, standard aids and appliances to promote physical, social, Physiological rehabilitation.

Rashtriya Vayoshri Yojana (RVY): The objective of the scheme is to provide free of costs Aid & Assisted Living Devices like Mobility Aids, Hearing Aids, Visual Aids etc. to Senior Citizens (age 60 years and above) from BPL (Below Poverty Line) category.

### **Procedure to avail benefits:**

<u>Phase I-</u> Assessment camps are conducted to identify the eligible beneficiaries as per schemes for providing Aids & Assistive Appliances.



<u>Phase II-</u> Distribution of assessed /identified Aids & Assistive Appliances to the beneficiaries in a camp mode.

ADIP-Sarva Shiksha Abhiyaan Scheme: Started from 2004 on renewable basis.
