# ARTIFICIAL LIMBS MANUFACTURING CORPORATION OF INDIA (A Government of India Enterprise)

#### **MEDICAL ATTENDANCE AND TREATMENT RULES 2024**

#### 1.0 SHORT TITLE:

These rules shall be called Artificial Limbs Manufacturing Corporation of India Medical Attendance & Treatment Rules, 2024 (hereinafter called the ALIMCO MATR Rules).

#### 2.0 OBJECTIVE:

The objective of the Rules is to provide medical facilities to the regular employees of the Company and their dependent family members relating to reimbursement; accordingly, these Rules are designed to provide a certain measure of social security and insurance to employees and their family members against various types of illnesses, which befall them during employment.

#### 3.0 APPLICABILITY:

- 3.1 These Rules shall apply to all (i) Regular employees of the Corporation and those on probation, extension (ii) those who are on deputation from Government Department/other Public Sector Undertaking who opt to be governed by these rules within month of joining the corporation. These rules are not applicable to "Casual Employee"/Apprentice/Contract Worker Engaged through Contractor. However, Fixed Term Contract employees/Casual Employees/ Engaged through Contractor (not their families) will be entitled to emergency treatment for the injuries occurred in factory/office/Outdoor Duty while on duty as may be allowed by the Competent Authority in his discretion. Additionally, Medical Insurance Facility shall be provided to Fixed Term Contract employees and their dependent family members only excluding their parents.
- 3.2 These rules shall come into force from (Partially with the date of approval of the BOD for OPD Treatment and full-fledged with the date of implementation of Medical Insurance Policy) and supersede all existing rules and ad-hoc orders now in existence. Medical facilities provided to the employees and their dependent family members are subject to modification / discontinuation at the sole discretion of the Competent Authority.

#### 4.0 **DEFINITIONS**:

- **4.1** "Company/Corporation" means the Artificial Limbs Manufacturing Corporation of India including its all Offices / Units under its management.
- **4.2** "Competent Authority" means Chairman & Managing Director of the Company, or any Officer authorized by CMD.
- **4.3 "Employee"** means all persons in the whole-time employment of the Company other than those, who are casual employees/ Apprentices/ Engaged through Contractor, work-charged and contingent staff and include those whose services are temporarily placed at the disposal of the Central or State Government or a local or other authority and those who are on deputation to the Company.
- **4.4** "Dependent Family Members" means a member of Employee's Family who meets the dependency criteria as specified vide Rule No. 5 herein under.

- **4.5 "Family"** means Employee's wife/husband, children and step children(including legally adopted children), parents. Wholly dependent on the employee.
- **4.6** "Pay" means Basic Pay and Dearness Allowance drawn by the Employee as on 1st day of April.
- 4.7 "Authorized Medical Attendant" for any category of Employees means Medical Officer (Regular/Contractual) of the Corporation irrespective of his / her grade or scale, Panel Doctor or Consultant from Panel Hospital, Medical Officer of Government Hospital, a hospital/dispensary run by a Local Municipal Body and other General Practitioner or Consultant who has approved qualification and has been registered under Indian Medical Council Act in Allopathic / or Ayurvedic or Naturopathy or Unani or Homeopathic System of Treatment. (Registered under NCISN/Other respective/concerned Government Authorities).
- 4.8 "Hospital" includes
- **4.8.1 Company's Hospital** means the Hospital/Wellness Centre/ Occupational Health Centre or Ambulance Room operated by the Corporation at Kanpur or any other Sites/Units/Places.
- 4.8.2 Empanelled Hospital refers to a private medical facility endorsed/enlisted by the Company at each Unit/Office for outpatient treatment of employees and their eligible dependent family members. Additionally, TPA's empanelled hospitals shall be considered for inpatient medical services/indoor medical treatment. The Company shall periodically update the list of empanelled hospitals for outpatient care, notifying employees accordingly. Reimbursement for outpatient treatment is contingent upon receiving services from the corporation's declared empanelled hospitals, while employees and their dependents can access inpatient medical services/indoor medical treatment from TPA's empanelled hospitals.
- **4.8.3** All Government hospitals / Municipal Corporation's Hospital.
- 4.9 "Medical Attendance" means attendance by the Authorized Medical Attendant including such methods of examination and such consultation with specialists for the purpose of diagnosis and Treatment as are considered necessary by the Medical Attendant and such consultation with specialist or other medical officer as the authorized medical attendant certifies to be necessary, to such an extent and in such manneras the specialist of medical attendant determine. Medical Attendance includes attendance at the Hospital (i.e., indoor as well as OPD) or at the residence of Employee or at the consulting rooms/clinics of Authorized Medical Attendant.
- **4.10** "Medical Treatment" means the use of all medical, surgical and diagnostic facilities in Hospitals which includes:
  - a) the employment of such pathological, bacteriological, radiological, or other methods as are considered necessary by the authorized medical attendant;
  - b) the supply of such medicines, vaccine, sera or other therapeutic substances not ordinarily so available as the Authorized Medical Attendant may certify in writing to be essential for the recovery orfor the prevention of serious deterioration in the condition of the employee;
  - c) such accommodation as is ordinarily provided in the hospital and issued to his status;
  - d) such nursing as is ordinarily provided to indoor patients by the hospitals;
- 4.11 "CGHS Rates" means Central Government Health Scheme (CGHS) rates.

#### 5.0 ELIGIBILITY OF DEPENDENTS FOR MEDICAL TREATMENT:

All the criteria mentioned herein below i.e., **5.1**, **5.2 & 5.3** are required to be fulfilled simultaneously for deciding Dependency for Medical Facility / Treatment:

#### 5.1.0 Criteria for dependency are:

#### 5.1.1 Residential Status:

Generally, all Dependent Family Members may preferably stay with the Employee. The condition of residing with an Employee by the Dependent Family Members including spouse shall not be insisted upon, subject to submission of documentary evidence in the following cases:

- a) Employees dependent parents, if staying anywhere in India.
- b) Children, if studying elsewhere.
- c) Spouse, if employed /unemployed, residing elsewhere.
- **d)**Dependent family members of employees posted at all ALIMCO Units / Centers located all over the country.

#### 5.1.2 Income:

- (1) For spouse (wife/husband, as the case may be) Income criteria will not be applicable.
- (2) Son, daughter including legally adopted children are deemed to be dependent on the Employee till they start earning.
- (3) The Parent will be considered as wholly dependent on an employee if the monthly income of the parents or the combined monthly income of both parents from all sources put together should not exceed the financial limit prescribed by the Government of India (from time to time) and adopted by the Corporation which at present Rs.9000 Per Month (plus the amount of Dearness relief, if any, admissible on the above amount in case of Government Pensioners), on the date of consideration of claim.

#### 5.1.3 Age:

- (1) Son including legally adopted, unmarried, dependent son are eligible for medical Treatment/facility till the age of 25 years or till he starts earning, whichever is earlier except Intellectual Impaired/ Permanently differently abled son.
- (2) Unmarried/Widowed Daughter including legally adopted daughter is eligible for Medical Treatment irrespective of age limit till she starts earning or gets married, whichever is earlier except Intellectual Impaired / Permanently differently abled daughter. However, to avail the medical facility for the dependent daughter, who completes 30 years of her age, the employeewill have to submit the declaration that she is still dependent on him. This declaration should be submitted in prescribed format available in Human Resource Department. The employees are expected to inform Human Resource department as soon as the daughter does not remain dependent on him.
- (3) Intellectual Impaired/Permanently differently abled Children of Employee on roll are eligible for medical facilities irrespective of the age. However, the IPD coverage shall be applicable as per the policy/terms & conditions of Medical Insurance/Group Medical Coverage (GMC) Policy.

#### 5.1.4 Marital Status:

Son, daughter including legally adopted children are eligible for medicaltreatment till they get married.

#### 5.1.5 Caregiver/Caretaker:

Unmarried PwD employees (more than 80% disabled) can nominate their caretaker/caregiver (only 1 person) for OPD medical treatment, however, in this case/scenario the parents of the concerned PwD employees are not entitled to get any medical benefits (OPD/IPD) from the Corporation. The nomination of caretaker/caregiver may be declared by the concerned PwD employees only once in a year.

#### 5.2 Other conditions for eligibility are: -

#### 5.2.1 Employed Spouse

The spouse of the employee working in other Govt. / Non-Govt. Organizations, which provides medical services to its employees, may choose either the facilities provided under these rules or the facilities provided by the organization in which the spouse is employed and to produce a certificate to this effect from their respective employer. Similarly, if both husband and wife are employees of the Corporation, only one of them may avail of the benefits of these rules for the family according to their option.

#### 5.2.2 Intellectual Impaired / Permanently differently abled Children:

Intellectual Impaired / Permanently differently abled son / daughter / legally adopted children of Employee on roll are eligible for medical facilities irrespective of the age limit. A certificate from Civil Hospital should be produced to this effect. Such cases will be considered on merit basis with the approval of Chairman & Managing Director. Thereafter, medical facility will be extended on yearly basis with the approval of Unit Head in case of employees of Units/HR Head at Corporate Office in case of Corporate Office employees.

#### 5.2.3 Intellectual Impaired / Permanently differently abled dependent Siblings:

Intellectual Impaired/Permanently differently abled siblings wholly dependent of those employees who have got their jobs in the Corporation on Compensatory ground, shall be eligible for getting medical benefits of OPD (as per policy) whereas IPD through CGHS rate/scheme only.

#### 5.3 Restrictions for dependency are:

#### 5.3.1 Female Employee:

Female Employees may opt either for her parents or her parents-in-law, as dependents, subject to meeting the criteria of dependency, with the liberty to change her option only once during the entire service.

#### 5.3.2 Widowed female Employee:

Widowed Female Employee may opt either for her parents or parent-in- law, as dependents, subject to meeting the eligibility criteria of dependency, till she gets re-married.

5.4 Every employee shall be required to furnish a declaration regarding the income and the residence of parents once in the beginning of every calendar year. Such declaration shall also include the names and details about age and income of other family members who are fully dependent upon the employee and normally residing with him. The Head of Department of the concerned employee shall verify and countersign the declaration before forwarding it to the head of HR Department. Any new inclusion and continuance of dependency shall be counterchecked by concerned HR Department before taking it on record with due approval of Head of HR Department in case of employees of all ALIMCO Centers/Units. A format of the declaration is enclosed at Appendix – I. Employees who fail to submit the said declaration upto 31st January shall not be entitled for reimbursement of medical expenses in respect of their dependent family members, except with specific approval of Competent Authority which may be accorded reasons

for not boing able to submit the same

- Addition of a family member as dependent may be allowed by the Competent Authority after due enquiry / consideration; if (i) Parents become dependent on the employee; (ii) Marriage of the employee takes place requiring inclusion of spouse's name; or (iii) Birth of a child.
- Deletion of a family member as dependent may be allowed by the Competent Authority; if (i) An existing member becomes ineligible to be included i.e., falling outside the scope of dependency; or (ii) Divorce of spouse; or (iii) Death of eligible member in the family.
- 5.7 Addition / Deletion of a family member from existing dependents list should be reported to the HR Department within a period of one month of its occurrence.

#### 6.0 OPD MEDICAL TREATMENT

#### 6.1 MONETARY CEILING FOR OPD TREATMENT:

- **6.1.1** Maximum limit for OPD treatment per family unit (eligibility criteria as per para 5 above) including dependent parents in a year for all diseases will be one (1) month Basic Pay + DA of the employee as on 1<sup>st</sup> April of the financial year. In case of new joinee who joins the corporation during the financial year, the initial basic + DA may be considered for this purpose.
- 6.1.2 The actual reimbursement of Out-Patient Department (OPD) medical expenses will be processed solely when the employee and their dependent family members receive medical treatment at Company's Hospitals/Wellness Centre/Occupational Health Centre or Ambulance Room or any Government hospitals / Municipal Corporation's hospital or a hospital that has been approved and empanelled by the Corporation. In the event that the employee or their family members seek medical attention at a private hospital not included in the Corporation's empanelled list, then no medical reimbursement shall be made/done by the Corporation.
- **6.1.3** The OPD ceiling in respect of new joined employees till completion of the service period of 05 years, will be reckoned on pro rata basis in case of retiring during the year.

#### 6.2 OPD TREATMENT & DIAGONISTIC TESTS:

- 6.2.1 OPD (outpatient department) is defined as a hospital department where patients receive diagnoses and / or treatment but do not stay overnight. Thus, OPD treatment is for patients who do not require hospitalization, expenses such as diagnostics tests, minor procedures, medicine bills, doctor's visit fees, dental treatment (RCT/Dental Implant/other than cosmetic treatment), etc. form a part of OPD expenses. In case of Eye treatment, employees and their dependent family members may claim cost of spectacles/glass lenses maximum upto Rs. 5000/- once in two years per family on the recommendation of an eye specialist of the Corporation's Hospital/Wellness Centre/Occupational Health Centre /Ambulance Room or Govt. Hospital/Municipal Corporation's Hospital/ empanelled hospital of the Corporation.
- **6.2.2** OPD treatment includes Allopathic, Homeopathy, Ayurvedic, Naturopathy, Unani treatment, Doctors consultation, diagnostic tests, medicines, minor procedures. It is notable that the treatment taken from Homeopathy, Ayurvedic, Naturopathy, Unani treatment may be reimbursed only if the same shall be taken from the Company's empanelled/ enlisted Hospitals, Govt. Hospitals/Municipal's Hospital.

### 6.3 MONETARY CEILING NOT TO BE APPLICABLE FOR OPD MEDICALTREATMENT IN CERTAIN CASES:

6.3.1 Reimbursement of Preventive Health Check-up and medical reimbursement for on-the-job accident cases shall be made over and above the monetary ceiling of one (1) month's Pay

#### 6.4 HOSPITALS FOR OPD MEDICAL TREATMENT:

- **6.4.1** Employees may take OPD Medical Treatment from the Company's Hospitals/Wellness Centre/Occupational Health Centre or Ambulance Room **or** any Government hospitals/ Municipal Corporation's Hospital or Empanelled Hospitals/Doctors/Clinics/Labs declared by the Corporation or its respective unit and actual reimbursement shall be made upon production of all documents, Doctor's prescription and receipts.
- **6.4.2** While on official tours where there is no enlisted/empanelled hospital affiliated with the Corporation, employees are permitted to seek Out-Patient Department (OPD) treatment from hospitals or doctors listed by Third-Party Administrators (TPA) in their empanelled facilities whereas these hospitals or doctors may not have been included or enlisted by the Corporation for OPD treatment. Additionally, this facility(exemption) shall be applicable on those employees (and their dependent family members) who are on approved authorized outstation leave. Reimbursement will be processed based on actual expenses, provided the employee submits all relevant treatment documents, doctor's prescriptions, and receipts for verification.
- **6.4.3** CMD may take OPD & IPD Treatment from anywhere. Reimbursement of expenditure on treatment will be made on actual basis upon production of all treatment documents, Doctor's prescription and receipts. Test reports are not required to be submitted.
- **6.4.4** The list of empanelled Hospitals for all the Units shall be declared/updated separately by the Corporation on time-to-time basis.

#### 6.5 REIMBURSEMENT BEYOND OPD CEILING:

- **6.5.1** In case, the expenditure of medical treatment has reached the OPD ceiling of an employee, actual expenditure incurred beyond the OPD ceiling for the following Chronic / prolonged Diseases only shall be reimbursed.
  - Cancer
  - Leprosy
  - Thalassemia
  - Chronic Active Hepatitis all form
  - Chronic Renal failure serum
  - creatinine> 5.0 or Renal Transplant Myocardial Infarction
  - Tubercular Diseases
  - Diabetes
  - Multiple Sclerosis.
  - Poliomyelitis
  - Ulcerative Colitis
  - Cardiac disease

#### 7.0 PERIODICAL HEALTH CHECK-UP FOR EMPLOYEES & THEIR SPOUSES:

- 7.1 Employees and their spouses shall be allowed the following tests under periodical health checkup once in two years up to the age of 40 years:
  - History & Physical examination by consultant;
  - Complete Hemogram Hb, TLC, DLC, ESR, Haematocrit, Peripheral Smear;
  - Blood Group ABO, Rh;
  - Blood Sugar Fasting & Post prandial;
  - Blood Urea:
  - Liver Function Test
  - Kidnev Function Test
  - Serum creatinine:

- Serum uric acid;
- Lipid Profile;
- Urine examination;
- X-ray Chest;
- ECG:
- Exercise Stress Test (TMT) or Echo (as decided by consultant)
- Review of reports and final consultation with Sr. Consultant, Internal Medicine;
- Gynaecologist Consultation and pap smear test.
- 7.2 Employees and their spouses shall be allowed the following tests under periodical health checkup once in a year above the age of 40 years:
  - History & Physical examination by consultant;
  - Complete Hemogram Hb, TLC, DLC, ESR, Haematocrit, and Peripheral Smear;
  - Blood Group ABO, Rh;
  - Blood Sugar Fasting & Post prandial;
  - Blood Urea;
  - Serum creatinine;
  - Serum uric acid;
  - Lipid Profile;
  - Liver Function Test;
  - Kidney Function Test;
  - Urine examination;
  - Ultrasound whole abdomen;
  - X-ray Chest;
  - ECG:
  - Pulmonary Function Test;
  - Exercise Stress Test (TMT) or Echo (as decided by consultant)
  - Review of reports and final consultation with Sr. Consultant, Internal Medicine;
  - Gynaecologist Consultation and pap smear test
  - Any other Test considered essential by the concerned Doctor.
- **7.3** In case of Preventive Health check-up, test reports are required to be submitted for reimbursement purposes.
- 7.4 Expenses associated with preventive health check-ups will not be factored into the calculation of the Out-Patient Department (OPD) ceiling (This means that the costs accrued from preventive health check-ups are exempt from being counted towards the limit imposed on OPD expenses), however, the preventive health check-ups should be done through enlisted/empanelled hospitals of the Corporation, only otherwise employees are not entitled to be reimbursed for the same.

- 7.5 All the Preventive Health Check-ups should be done through only empanelled Hospitals/Labs enlisted/updated/declared by the Corporation only so that the reimbursement may be done/made accordingly. The maximum ceiling of the preventive health check-ups is Rs 5000/- (per person).
- 7.6 In case Corporation is organizing Preventive Medical check-up then NO reimbursement shall be made.
- 7.7 In case of Directors & CMD, for whom annual medical check-up is compulsory under the Annual Performance Appraisal Rules, the reimbursement of expenditure will be on actual basis for the type of tests /investigations prescribed under Govt. Rules or any other test / investigation prescribed by the specialists at the time of undergoing annual check-up specified in these Rules.

#### 8.0 INDOOR MEDICAL TREATMENT

IPD (Inpatient Department) is defined as a hospital department where patients received diagnoses and/or treatment but to stay overnight. Thus, IPD treatment is for patients who require hospitalization. Expenses, such as Diagnostics tests, procedures, medicines, Doctor's Visit fees, dental treatment, Room Rent, operation theatre, nursing, cost of stents. Cost of implants etc., form a part of IPD expenses.

For providing facilities of indoor medical treatment to its employees and their dependent family members, the Company shall take Group Medical Insurance Policy on time to time.

**Eligibility:** All regular employees and their dependent family members are covered under the Policy for the purpose of indoor treatment of surgical and non-surgical ailments. The policy is serviced by a Third-Party Administrator (TPA) and the insured persons get the benefit of 'cashless indoor treatment' from the listed hospitals. In case of treatment in unlisted hospitals, the cost will be reimbursed by the Insurance Company on submission of claim, subject to the other terms of policy.

The ceiling of annual medical coverage per family unit for various categories of employees, is as under: -

#### \* FTC Employee's parents are not covered through GMC Policy.

In addition to above, Company shall take a Company/Corporate Buffer/floater plan with Group Medical Insurance Policy to consider claims over the coverage on indoor treatment for employees and their family members. Such claims be may be considered by the Competent Authority on merits of the case up to 100% of Sum Insured, however, the Chairman & Managing Director may relax and extend the % of the Sum Insured (beyond 100%) of the Corporate Buffer/Floater as per his/her discretion on case-to-case basis.

The Ceiling Amount/Annual Medical Coverage for family Unit may be reviewed once in every two years and shall be updated on time-to-time basis (if required.)

The ceilings on room rent, ICU charges, on a particular procedure, maternity, ambulance charges, eye, dental treatment etc. are notified as a part of policy from time to time.

It is notable that in any case wherever the IPD/Indoor Medical Insurance Policy as well as Corporate

Buffer/Floater plan is exhausted then the reimbursement shall be done through CGHS Rules/Scheme and its defined rate and difference of the actual expenses and reimbursed amount shall be borne by the employee only.

#### 9.0 TA for outstation medical reference for OPD & IPD treatment:

9.1 Railway Fair for patient and one attendant will be admissible to an employee as per his/her entitlement under traveling allowance rules for medical treatment of him/herself or members of his/her dependent family from the place of posting to the referred place. However, prior approval of the Competent Authority will be required for all such visits for outstation treatment.

#### 10.0 Medical Advance

- 10.1 Chairman and Managing Director may grant specific advance to an employee of the Corporation to meet expenditure on their own medical attendance and treatment of or that of their families keeping in view the exigency of the IPD treatment only wherever the Sum Insured & Corporate Buffer/floater is exhausted or the expenditure cannot be meet/fulfilled through Mediclaim Policy/Medical Insurance.
- 10.2 The advance will be granted only on the recommendations of the Medical Officer of the Corporation who would indicate in each case the expected duration of the treatment and likely expenditure. Note: In case where the Medical Officer of the Corporation is not available in that case the Head of HR Department may give the recommendation.
- 10.3 The amount of advance will be limited to three months' pay of the employee or such other amount as the Medical Officer / Authorised Medical Attendant/HOD HR or the specialist may recommend, whichever may be less. So long as the total advance does not go beyond this figure, the advance may be drawn for one illness in more than one instalment as may be estimated and recommended by the AMA/Medical Officer/Specialist.
- 10.4 The advance will be adjusted against the admissible Medical Reimbursement claims submitted by the employee for the illness and the balance of advance or difference amount paid to hospital and amount of entitlement, will be recovered from his/her pay. In absence of an adjustment presented by the employee within the time specified the advance will be recovered in six equal monthly instalments from the next month from the date of advance.

#### 11.0 Restriction on reimbursement

- 11.1 Substitute medicines, Cosmetics products, soaps, oils, food supplements, any device measuring medical condition, such as thermometer, pulse oximeter etc., shall not be reimbursed & Cosmetic dentistry & lasik surgery shall not be reimbursed as these focuses on improving the appearance. Substitute medicines shall be reimbursed, if verified by the treating doctor /Medical Officer of the Corporation.
- **11.2** Medicines shall be purchased within 4 days from the date of prescription.
- 12.0 SUBMISSION / PROCESSING / SETTLEMENT OF CLAIMS

#### 12.1 Submission of OPD Claims:

- **12.1.1** Employee may submit the OPD claims to HR Department (in case of Corporate Office) or Unit Heads (in case of Units/ AAPC/ RMC/PMDKs) once in a month in the prescribed form along with treatment documents, Doctors prescriptions, Receipts, Cash memos of the chemist for purchase of medicines. Test reports are not required to be submitted.
- **12.1.2** If medicines prescribed by the treating doctor are for more than one month, the employee may purchase the medicine on month-to-month basis, for which reimbursement shall be

allowed on month-to-month basis on the same prescription. However, necessary entries in this regard shall be made by the dealing official on the original prescription.

#### 13.0 Submission of Indoor Medical claims -

**13.1** Employee may submit medical claims to the Authorized person of Third-Party Assistant of the Insurance Company.

#### 13.2 Medical Attendance for the employees on tour to Units/Offices

When the employee is on tour other Units, he/she will be treated as the employee of that particular Unit/Office for the purpose of medical attendance. He / She can take medical treatment (both OPD and IPD) from the empaneled hospital of the concerned Unit/Office to which the employee has come on tour.

#### 14.0 EMPANELMENT OF HOSPITALS

14.1 To have better administrative control, the following committee will be constituted for the Units/Offices to review the empanelment of Hospitals/Specialists or amendments in the medical facilities: -

#### HQ, Kanpur

#### **Units and RMC**

Unit Head/RMC Incharge Chairman
Repn of Finance/HR Deptt Member
Repn of Operation Deptt (if available) Member
Repn of Mktg Deptt Member

- 14.2 The Committee will meet once in two years preferably in the first quarter of the financial year and submit its recommendations to Head –HR at HQ, Kanpur. Afterwards, the same shall be reviewed by HQ/Corporate Office and a Circular shall be published separately in this regard.
- 14.3 Following Hospitals / Nursing homes may be preferred for empanelment, if they provide:
- 14.3.1 All specialty under one roof
- **14.3.2** Facility of minor / major operation:
- **14.3.3** Agree to provide medical facilities on CGHS rates
- 14.3.4 Government and Govt. aided hospitals
- **14.3.5** In the District/Town where units are located, hospitals having at least 15-20 beds.

#### 15.0 SAFEGUARDS AGAINST MISUSE OF MEDICAL FACILITES

- 15.1 The above changes in the Medical Policy have been made to mitigate the difficulties faced by the employees and the same will be reviewed after twelve months.
- 15.2 The Company's medical facilities are provided to the employees as a welfare measure. The facilities are intended to be utilized for its rightful purpose. However, in the event an employee is found guilty of misusing the medical facilities, he will be liable for strict disciplinary action under the Rules. Accordingly, following safeguards are provided against misuse of medical facilities: -
- 15.2.1 Controlling Officers will be expected to exercise a great vigil for reimbursement of medical

- **15.2.2** Management, at its discretion, shall have the right to demand the employee to produce the medicines for physical verification. The management shall also have the right for physical verification of the medicines purchased in doubtful cases.
- 15.2.3 Management shall have the right to refer medical expense claims including directing the patient for examination by any other Doctor nominated by the Management to ascertain the genuineness of the claim. The Management's opinion shall be binding on the employee.
- **15.2.4** In case an employee or his dependent family member is hospitalized, the employee should immediately inform the Management. Management may verify the genuineness of the hospitalization.
- 15.2.5 In cases where the medical reimbursement bills are considered to be of not genuine nature, such bills along with prescription shall be referred to CMO/Medical Officer/Nominated Doctor of Company for a second opinion and if a claimis found to be inflated or not of genuine nature by the CMO/Medical Officer/ nominated Doctor, the claim shall be rejected in its entirely apart from initiating such disciplinary action, as the Management may deem fit.
- 15.2.6 If claims for reimbursement are too frequently received from an employee or if claims are or large amounts, such claims shall be subject to investigation by the Management, followed by further necessary action, as deemed fit by the Management.
- **15.2.7** At any point of time in any particular case, Management shall have the right to insist on the employee to obtain medicines either from a Chemist nominated by the Company.
- **15.2.8** In case of claims of dependent parents, the company shall have the right to verify the bonafides even including physical verification/ visiting the residence of the employee.
- **15.2.9** Management may also consider appointing a panel of Chemists at different locations for purchase of medicines by the employee of that location.
- **15.2.10** In the event an employee is found guilty of misusing the medical facilities, the same shall entail strict disciplinary action under ALIMCO Employees (CDA)Rules/Certified Standing Orders, depending upon the severity of the case.
- **15.2.11** Management shall have the right to review/revise/withdraw the medical facilities with the approval of the Competent Authority.
- **15.2.12** The list of dependent members of the employees has to be scrutinized from time to time, with a view to ensure that no employee claims medical facility for non-entitled members.
- 16.0 Interpretation and relaxation
- **16.1** Where Artificial Limbs Manufacturing Corporation of India (ALIMCO) Medical Attendance & Treatment Rules (MATR) are silent, Central Government Health Scheme (CGHS) Rules shall be applicable.
- **16.2** Wherever any doubt arises with regard to implementation of Medical Attendance & Treatment Rules, the matter shall be referred to Corporate Office.
- 16.3 Any deviation in ALIMCO MATR shall require special approval of CMD. Such cases, duly recommended by Unit Head as well as HR Head -Corporate Office/HQ, be put up before CMD for consideration.
- 16.4 CMD, may, from time to time issue such orders as may be expedient for the purpose of the

proper administration of these regulations including the adoption of such safeguards as are necessary to make such provisions as are expedient for the purpose of providing such cases or category of cases or any circumstances or category of circumstances as are not adequately covered by these regulations.

- 16.5 The CMD has the authority to interpret these regulations and to modify / withdraw any of these rules without previous notice of its intention and to give effect thereto from the date of issue or from any other subsequent date. In case of any doubt or dispute in regard to interpretation of these Rules, the decision of the CMD shall be final.
- 16.6 The CMD will have the authority to allow any person for any medical treatment in any hospital within India in cases where medical condition of such patient so requires.
- 16.7 The CMD will have the authority to approve relaxation of any of the provisions of these Rules and / or the supplementary rules and / or the amendments issued thereto in respect of a category or categories of employees for reasons to be recorded in writing. However, he may at his discretion seek a decision of the Board of Directors on matters involving substantial questions of policy.
- 16.8 In case any particular aspect related to the medical facilities is not covered in these Rules, the matter shall be referred to CMD for taking a final decision, which shall also be updated in these Rules.

#### **GUIDELINES FOR OPD REIMBURSEMENT CLAIM**

The following guidelines are to be adhered to in order to facilitate regular employees in covering the costs of their own medical attendance and treatment (including Outpatient Department services and diagnostic tests) or those of their dependent family members: -

 Submission of Reimbursement Claim: The employee must submit the OPD reimbursement claim using the provided "Claim for Reimbursement of Medical Expenditure" form enclosed herewith. The claim must be accompanied by all relevant documents, including doctor's prescriptions, diagnostic reports, and detailed medical bills.

#### 2. Submission Process:

- a) Employees based at headquarters should submit their OPD reimbursement form, along with all relevant documents, to the Corporate P&A Department after verification by their respective Controlling Officer/HOD.
- b) **Employees posted at AAPCs/RMCs/PMDKs/Units** should submit their claims to their respective Controlling Officer at the concerned location. Once verified and approved by the Controlling Authority/Unit Heads, the claims will be forwarded through courier/speed post (including scanned copy through email) with a covering letter (containing the details of the claim) to the Corporate P&A Department for further verification and approval.

#### 3. Submission Deadline:

- 4. The procedure for submission and processing of OPD claims requires employees to submit their claims to their Controlling Officer within 7 days of availing medical treatment. The Controlling Officer must verify the claims and forward them to the Corporate P&A Department within 15 days. However, if an employee submits their claim to their Controlling Officer beyond 7 days of availing treatment, the same will only be processed with the prior approval of the concerned General Manager (GM).
- 5. **Verification and Review**: After receiving verified claims from the respective Controlling Authorities (I/c AAPC/RMCs or the concerned HOD at HQ), the Corporate P&A Department will review the claims in accordance with the terms and conditions of the **Medical Attendance and Treatment Rules, 2024**. Additionally, the Corporate P&A Department shall also check the eligibility/entitlement of the reimbursement as per the MATR-2024 vis-a-vis all OPD medical claims are verified by the Corporation's Medical Officer. The Medical Officer will review the claims to verify the legitimacy of the treatment and cross-check prescribed treatments and medicines against standard medical practices.
- 6. **Final Approval and Payment Processing**: The Corporate P&A Department will give final approval, ensuring medical validity before processing payments. A list of approved medical reimbursements will be prepared and sent to the F&A Department for payment processing. Upon receiving the information, the F&A Department will disburse the payment for OPD medical claims. The Corporate P&A and F&A Departments will also monitor the capping limit for each employee.

#### Note:

- a) Unusually high claims or repetitive patterns of medical reimbursement from the same employee may trigger further review/investigation of the documents by P&A Deptt./Medical Officer.
- b) The list of empaneled hospitals for OPD purpose is enclosed herewith.
- c) With due course of time a centralized online portal system shall be implemented where all employees across branches can submit their medical reimbursement claims. The portal shall allow employees to upload scanned documents such as bills, prescriptions, and diagnosis reports, which will be directly accessible by the Corporate P&A.
