Sub:- Procurement of BIS Certified (ISI-Marked) Items preferably by the Corporation.

Sir/Madam,

As you are aware that Artificial Limbs Manufacturing Corporation of India (ALIMCO) is a Miniratna CPSE under the Administrative Control of Department of Empowerment of Persons with Disabilities (Divyangjan), Ministry of Social Justice & Empowerment (MoSJE), Govt. of India. The Corporation is engaged in the manufacturing & distribution of Aids & Assistive Devices for Divyangjan & Senior Citizen under Govt. of India schemes since last 50 years (approx). In view of continuous change in the requirement of Aids & Assistive devices due to technology updation and to meet with the pace of time, the Corporation is reviewing and updating its manufacturing facilities through modernization of plant and machineries.

As per the guidelines issued by Govt. of India, purchases through GeM by Government users have been emphasized by the Ministry of Finance. The GeM platform is owned by GeM SPV (Special Purpose Vehicle) which is under the Ministry of Commerce and Industries, Government of India. Further Department of Expenditure, Ministry of Finance, Government of India has also recently released guidelines for Procurement. Accordingly the Corporation is putting efforts for procuring quality products and manufacturing Aids and Assistive devices of good quality accordingly. The Corporation is reviewing its requirement and technical specification of components in-line with new guidelines and intends to procure BIS Marked raw material/component/bought outs etc. in its procurement wherever BIS standards are available.

In view of the above, the Corporation advises to all its existing, prospective vendors including Micro & Small Enterprises (MSEs) to get their products (whether Raw Material or other products) ISI certified and arrange for BIS marked licenses so that they are not left behind when the Corporation asks for ISI marked licenses for their supplies and due preferences are given to BIS marked raw material and product in accordance with procurement guidelines of Govt. of India.
